## The Journey so far.....

Recognizing the immense needs that the rural poor in Rajasthan had, a group of socially conscious individuals formed the organization, Gram Chetna Kendra in 1986. Under the leadership of Mr. Om Prakash Sharma, these individuals combined their unique talents, knowledge, skills and experiences to address the pressing issues that the communities of Rajasthan faced. Gram Chetna Kendra, which translates to Village Awareness Center, was registered as a voluntary, non-government organization under the Societies Registration Act and began formal operations from their premises located at the village of Khedi Milak, which is in the heart of the project area. Khedi Milak is located approximately 55km away from Jaipur, the capital of Rajasthan, in the Sambhar Block of the Jaipur District.

Prior to GCK's work in the area, it had remained virtually untouched by any mainstream development efforts, neither national nor international sources. Throughout the years, GCK has sustained a range of various activities through funding and support. Initially, the projects were solely focused on improving the welfare of the rural poor through providing them with basic needs, but the organization has since grown and evolved. Now, their mission is to focus on capacity building of the community so that they can help people help themselves. Their goal has become human resource development, improving on peoples' abilities to recognize their potential and to do this in a way that works hand in hand with their natural environment.

As very familiar to the immense needs of Rajasthan's rural poor, this group decided to combine their unique knowledge, talents, skills and experience to address the pressing issues that individuals face. Started with 2 villages of Sambhar Lake area, the organization has been grown up and working in 11 districts of Rajasthan. Currently Gram Chetna Kendra working 3 Districts of Rajasthan (Jaipur, Alwar & Kota).

#### **THEMATIC AREAS and PROGRAMS**

The Organization is associated with many National, International and UN organizations as a partner for implementing projects in different sectors. Our major Programs in the financial year 2017-18 are described in subsequent paragraphs.

#### Health, Water & Sanitation

#### **Family Helper Project**

Gram Chetna Kendra is implementing Family Helper project in 33 selected villages and associated hamlets of Phulera Tehsil of Jaipur District & Tijara Block of Alwar district covering approximately 38525 persons which includes 18367 female and 20158 male populations in collaboration with Child Fund India. Family Helper Project is a sponsorship based program benefitting individual children, their entire family and community. The project aims to address the needs of the community through an integrated plan of distinct components.

#### Healthy and Secured Infants

In Family Helper Project we address the poor attendance of 3-5 age group children in ECCD centers in 33 villages. The Project reach to preschool children (3-5 years) in all villages ensuring through improvements in quality of ECD services provided by preschool with a combine strategy of strengthening AMC/BMC and skill training of preschool teachers. The Parents and caregivers are sensitized for healthy secured infants and children.



#### Community owned Safe Drinking Water

10,000 liters water each day filtered and 600 families of 5 village's & 470 Govt. School children get benefitted directly. There is high limit of floride, selenium, arseic, and nitrate in water. Excess of each specific ion causes health hazards through the deficiency or toxify to the soil plants human and animals. A selected youth, one from each village have trained to repair water treatment plant as well as distribution system maintenance at village level.

#### **Give India Donation option Program**

Water Tank Structure for Poor Families-The project villages in which GCK operates are dry, drought-prone area where the scarcity of rainfall causes the scarcity of water and the levels of fluoride content increases. Families must walk 1-3 km to fetch water for drinking and other basic needs. The non availability of safe drinking water in the village is also a major problem which haves a bad effect on health. So GCK with the support of Give India provide finance for construction of underground tank of dimension 8' x 10' (7000 liter capacity) in their premises of home. The underground water level is very low and chance of getting source of safe



drinking water is very less so rain water is collected from the roof to the underground tank through the pipe. The first rain water is discharged outside the underground tank since the roof of the house is very dirty and the rain water get contamited so clean rain water is collected in the underground tank and used for cooking and drinking. Through Give India, we have been able to construct ground water storage tanks.

In order to maintain these structures, we educated them on roof water harvesting during the summer months and how the tanks function. This year, we were able to fund construction of 33 tanks for families in the area and provided safe drinking water and security to families.

**Toilet Construction**-This aspect of the project consists of 2 different parts. One part is to raise awareness on proper sanitation while the other is the actual construction of toilets for families. Throughout the year, GCK receives funds to construct low-cost toilets for very poor families. This year, families were educated on proper sanitation and hygienic practices and **19** families received benefit for construction of toilets at their houses.



In the 63 villages of Ramganj Mandi Block of Kota District & Sambhar Block of Jaipur district Inclusive Development for the Children & Youngster with Disability" is a program which covers the 465 disabled children and youngsters. The basic motto of this program is to make the disabled independent and self-reliant. Mainstreaming the handicapped in the society. 172 children are getting regular health check-ups. Home based Health hygiene practices 55 children received Hygiene material distribution 60 ADL trainings (Hand wash, toilet training, bath training, tooth brushing, nail cutting,

wearing etc.) 103 assisted equipments were provided. 5 DPO formed

#### **Education & Child Rights**

**Support for a Poor Young Education**-In this aspect of the project, with the support of Give India we help support young, aged 6-14, continue their education by providing them with materials and supplies to motivate them towards schooling. Young folks from poor families are chosen and they receive items that would help further their interest in education as well as maintain proper hygiene.

Basic Building Skill Model- In the Sambhar Block of Jaipur district & Tijara Block of Alwar district the



BBS model run with the 342 children in 11 centers. The Program have focused on improving the learning levels of irregular and academically weak children and re-enrolled children to ensure their continuity in schools. Programs have also worked with teachers and build their capacities in better handling children within classroom and resort to less physical punishment or intimidation.

The children due to the learning gaps in their basic skills are not able to continue with their education as they find it

hard to cope with the curriculum as it progresses with each passing grade. So this program model facilitates the acquisition of basic skills in the children who are struggling with the learning gaps. These centers have cater to both kind of children with learning gaps – those who are already in school but are struggling with the grade appropriate curriculum as well as those who are out of schools (never enrolled or drop outs). 6 libraries establish in community.

#### Building a protective environment for children Program

Community based Child Protection- This CP model have covered in 20 villages in Sāmbhar block of Jaipur district, Rajasthan. To improve the safe and protective environment for the children in the area, we are working with child protection committee members, parents and caregivers, SMC and PRI members, teachers, police, local leaders, ANM, AWW and other important stakeholders.

GCK has established child clubs across with 400 children in 20 villages. These children are active change makers within their homes, community and schools. The program have worked to build the capacities of children and promote their active participation in addressing the key issues related to CP - child labour, early marriage, gender discrimination etc. The program have used different platform and create opportunities for children to raise their concerns and solution for the CP related problem from their perspective.

#### Livelihood

#### Youth involved in quality learning

The prime focus of the Child Fund Project to promote youth participation in different program cycle in the area. Skill Trainings was provided to youth leaders. Youth learned about youth organisation, their objectives and role in villages for speed up the development. The meetings are organised with Youth and Women for identifying skills gaps as well as their skills up-gradation needs and accordingly planning and designing skill courses for them.

#### skill development- Embassy of Japan

As a token of friendship and cooperation between Japan and India, Embassy of Japan in India has supported us a Grant in Aid for construction of a Vocational Training Centre building at village Khedi Milak in Sambhar Block of Jaipur, Rajasthan. As a part of a new milestone in the life of the organization, this Vocational Training Centre will play a vital role in promoting skills of youth and women of this backward region for creating new avenues for their livelihood and productive and gainful sustainable employment. Globalization of manufacturing and technological advancements has led to this sector becoming more strategic than operational in nature.

Livelihood Promotion program Supported by BOSCH Company in selected villages of Bassi of Jaipur District in Rajasthan- Enhance mindset towards Organic farming among people as better option for their livelihood which is beneficial for marginalized farmers. Farmers got awareness on govt. schemes and its subsidy. Household income increased among poor farmers in the community. Through vermi -compost land becomes arable for farming and greater production. By availability of drips and mini sprinkle the conservation of water raised in the areas of



less rain-fed rural Rajasthan for poor folk as blessing for production. 21 farmers got benefited through group. A positive change came among farmers and SHG group. Through group people could share family problems and agriculture and animal husbandry challenges for a solution. Over all 358 male and 509 female in total 867 farmers got benefited.



Community owned Vocational training for the vulnerable, marginalized and school dropout youth of Jobner Block Jaipur district of Rajasthan State supported BY FVTRS- In the beginning of the program we have invited peoples form Sambhar block those are connected with village development committee, SHGs Women federation, youth groups and members of Village Panchayat to give them training & knowledge regarding the program and we made them aware that this is their responsibility to give this knowledge to need youths of

their area. By this training program many youth came to us to take training, for final selection process we have gave them counselling as per their interest and need, like this we have done selection of youths in each trade. After final selection as per the schedule of each trade we have given training to the youth in which we have mostly focused on practical.

#### **Economic Enhancement under Federation**

GCK has formed 1 federation to manage revolving funds and support for livelihood activities: Gram Chetna Adarsh Mahila Bahuudheshiya Sahakari Samiti Ltd. (a federation of self-help groups registered under Rajasthan Cooperative Society Act). The trainings were provided to the SHGs. Leadership development trainings were provided to the Federation members. Financial assistance is being provided by disbursement of loans to small business. We had strengthened **92** SHGs with more than **1200** members. The loan recovery rate is almost 100%. Income generation activities like – goat rearing, buffalo are being provided to the SHG women.

#### Some of the key outcomes of the year are as follows:

- 03 women have open fancy store with the help of SHG group.
- The loan is disbursed mainly under the head of Dairy farming & goat rearing.
- External funding agency for SHG group is ICICI bank
- 100% recovery of loan from the members of the SHG group.

**Civil Society Organizations (CSOs) Convention on Gender Based Violence against Women and Girls IN ALWAR, Rajasthan-** Taking the initiative, a little further, Save the Children in partnership with Gram Chetna Kendra, Alwar is organizing an event in the form of a convention by representatives of Civil Society Organizations on the issues of GBV to identify key challenges and opportunities and to suggest ways to combat gender based violence against women and girls on 3rd November, 2017.

Some important recommendations from the workshop:

"The most important factor to be borne in mind is that the responsibility of child protection should be initiative by civil society organization who are sensitive to the issues of children and identifying their limits that where they are capable to raise and address child protection issue" said by panel of Raghunandan Sharma, Govind Beniwal and Meeta Singh. Due to the lack of political and bureaucratic will, effective rehabilitation remains a challenge. So it's need to developed common strategy which will be helpful for preparation of recommendation.
